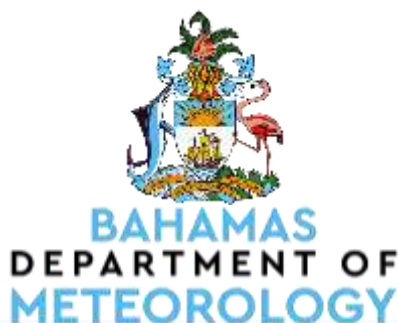

⚠ SEVERE WEATHER WARNING UPDATE ⚠

THE BAHAMAS DEPARTMENT OF METEOROLOGY HAS RE-ISSUED A SEVERE WEATHER WARNING UPDATE ON WEDNESDAY, SEPTEMBER 23, 2026 FROM 9:55 PM EDT UNTIL 11:00 PM EDT.

A SEVERE WEATHER WARNING IS NOW IN EFFECT FOR THE ENTIRE ISLAND OF ELEUTHERA ALONG WITH ITS ADJACENT WATERS AND CAYS.

A SEVERE WEATHER WATCH REMAINS IN EFFECT FOR THE NORTHERN & NORTHWEST BAHAMAS.

AT 9:42 PM EDT, OBSERVATION, RADAR AND SATELLITE IMAGERY CONTINUED TO DEPICT A ROBUST CLUSTER OF HEAVY SHOWERS WITH EMBEDDED THUNDERSTORM ACTIVITY MOVING OVER THE WARNING AREAS. THESE SHOWERS AND THUNDERSTORMS ARE ASSOCIATED WITH ABUNDANT TROPICAL MOISTURE, COUPLED WITH A MID TO UPPER-LEVEL DISTURBANCE AND PREFRONTAL ACTIVITY.

SOME OF THESE SHOWERS AND THUNDERSTORMS WILL BE SEVERE AT TIMES CAUSING STRONG GUSTY WINDS, DANGEROUS LIGHTNING, HEAVY DOWNPOURS, FLOODING, HAIL AND POSSIBLE WATERSPOUT OR TORNADIC ACTIVITY.

BOATERS IN THE WARNING AREAS SHOULD SEEK SAFE HARBOUR AND RESIDENTS IN THE WARNING AREA SHOULD STAY INDOORS AND AWAY FROM WINDOWS WHEN CONDITIONS WORSEN. RESIDENTS SHOULD NOT SEEK SHELTER UNDER TREES OR IN WATER AS THESE CAN BECOME LIGHTNING CONDUCTORS.
